#### Deadline for vision claims

# FINANCIAL SERVICES CONT.

#### **Grants and Contracts Reminders**

1. HR/Payroll related matters:

a. **Approved ETF's** must be submitted two weeks to one month before starting to log time on your grant: Use notes section for detailed comments and dates (<u>fdnhr@cpp.edu</u>).

b. **Student/Part time** employees are not eligible to work over 1,000 hours in ONE fiscal year July 1 through June 30.

i. If the employee goes over these hours, they become eligible for CALPers and your budget will be affected.

ii. Keep this in mind when you are approving hours and the employee is working on multiple grants.

iii. A 1000-hour report is available in UKG/Kronos to monitor that they are not exceeding the limit (If you need assistance, please reach out to payroll: <u>fdnpayroll@cpp.edu</u>).

c. **Faculty Summer** hours can be claimed ONLY during the summer, winter break and spring break.

d. Do not submit hours during the academic years unless you have been approved for OVERLOAD. Please review your budgets.

e. HOURS must be logged in UKG/Kronos during the period for which you are working.

f. **ONE TIME PAYMENT**- Are reviewed on a case-by-case basis: Use the notes section for detailed comments and dates.

g. All **new or terminated employees** being hired or rehired will need to be **verified by HR and provide I9**.

h. You must submit an ETF to terminate the employee once you have expended all salary/benefits funds on your grant or when the grant ends, whichever comes first. 2. When approving hours please confirm the cost center being charged for that employee is correct.

a. If there is an incorrect charge on your grant, if will be your responsibility to:

i. Complete an IDT.

ii. Obtain an earnings register for that employee.

iii. A memo from the employee stating the hours.were supposed to be for another project and an explanation for the transfer of expense.

3. EFFORT Certification Forms - Reporting must be submitted on time. Top portion Part A should be provided at the beginning of the semester/bottom portion Part B finalized at the end of the semester.
